


# The Rock Install Guide



### Installation Prerequisite

#### Installation to be performed only by certified installer

Power Sourcing Requirement: PoE+ (802.3at Type 2) 30W

PoE+: UL 294B and UL 1310 Class 2 LISTED / APPROVED power source is mandatory to maintain UL 294 Listing Status

A ULC 60839- 11- 1 and CSA C 22.2 No 223 Class 2 power supply must be provided for ULC installations

Wiegand/OSDP Badge Reader max cable length: 5 ft - 22 AWG (1.5 m)
Wiegand Panel max cable length: 500 ft - 22 AWG (152 m), 300 ft - 24 AWG (91 m)
OSDP Panel max cable length: 4000 ft - 24 AWG (1,219 m),
max length between nodes: 1640 ft - 24 AWG (500 m)





### Mount 2-gang switch box in wall




### Alternate corridor install for tight spaces






### Step 2 -

Wire cable harness to badge reader and access control panel

#### **OSDP** wiring table

+12v *	RED
GND *	BLACK
+ RS485A *	GREEN
– RS485B *	WHITE
Beeper	YELLOW
Tamper	VIOLET
Hold	BLUE
LED Green	ORANGE
LED Red	BROWN

<sup>\*</sup> Wires in RED are required

It is possible to reuse existing Wiegand wiring for OSDP, however, using simple stranded cable typical of Wiegand access control readers does not meet RS485 twisted pair recommendations

For OSDP cable lengths greater than 200ft. (61M) or EMF interference, install 120 $\Omega$  +/-  $2\Omega$  resistor across RS-485 termination ends

#### Wiegand wiring table

+12v *	RED
GND *	BLACK
D0 *	GREEN
D1 *	WHITE
Beeper	YELLOW
Tamper	VIOLET
Hold	BLUE
LED Green *	ORANGE
LED Red *	BROWN

<sup>\*</sup> Wires in RED are required

LED wires are required for wiegand installations

For wiegand installations that require 1-Wire LED control, ONLY connect the ORANGE wire (Panel LED Green) to the LED terminal on the panel



### Step 3 -

## Thread cables through and attach wall plate to 2-gang box


Attach wall plate to 2-gang box with provided flat head screws, paying attention to point the arrow towards door

Installed screw heads must be flush to the wall plate. Protruding screw heads will cause interference when installing the Rock onto the wall plate




#### Check level on wall plate

Use flat surface on side of cable tunnel to check level and adjust as needed






### Step 5 -

### Attach Rock to wall plate

①Press narrow edge onto wall plate at slight angle ②Pivot to latch Rock into place




#### **CAUTION:**

Do not press on glass lens cover during installation, glass may break

#### ATTENTION:

③To attach or remove Rock from wall plate, tighten or loosen set screw on lower edge of vent mesh



The Rock has TAMPER detection: Removal of Rock from wall plate will result in TAMPER signal assertion to ACS

### Step 6 -

#### Post installation check

#### Rock Power up

The Rock must have PoE+ (802.3at Type 2, minimum 30W) plugged into a reliable source to provide the Rock with sufficient power

The bootup sequence will not be successful if the Rock does not have sufficient power, and may go into a reboot loop

#### Booting

Status icons and a progress bar appear in the main display to indicate booting and will complete in approximately 2 min



#### Running

By default all new Rocks start in demo mode until configured - this will be indicated by the word DEMO down the left side of the display



One or more of the following status icons may be present in the status bar on the display after bootup



QR Code read active

Server connection bad

Not on-boarded to server

Person in range

\* Must be resolved before completing install

The installation is not complete if any of the following errors are present, these errors must be resolved to complete the installation










### Step 7 –

### Post installation functionality verification

- 1. Make sure all fault messages are cleared (see step 6)
- 2. Swipe badge\* (badge must have access to door in ACS)
- a) Rock and badge reader will flash the same color
- b) Gray badge icon turns green

Match LED color on Rock and badge reader



Gray to Green badge icon



Door should unlock and the installation is now complete, you may proceed with commissioning - access the Alcatraz Al Admin Portal Guide by scanning the QR code on the back cover of this document for more info

\*If a mask is being worn, an animation to pull down the mask will be displayed - it is not necessary to remove the mask to swipe badge






VESA Mount Adapter (RCK-VESA-01)




EU/UK Wall Plate Adapter (RCK-EUR-PLT-01)

### Alcatraz Al Warranty

The Alcatraz Al limited warranty does not include service to repair damage to the product resulting from installation or service by other than an Alcatraz Al certified installer. Go to support.alcatraz.ai to request a login to take the free, online Certification Training.

### Limited Warranty and Limitation of Liability

Alcatraz Al warrants that the products shall be free from material defects for a period of one (1) year from the date of purchase (the "Warranty Period"). This warranty shall apply only to the original purchaser unless the buyer is authorized by Alcatraz Al to resell the products, in which event this warranty shall apply only to the first repurchase.

It is necessary to obtain a Return Material Authorization (RMA) number before returning suspected defective products to Alcatraz Al. An RMA number may be requested by contacting Alcatraz Al support at support@alcatraz.ai. The RMA number must be written on the documentation accompanying the return. If the product is delivered by mail or by an equivalent shipping carrier, the purchaser agrees to insure the product or assume the risk of loss or damage in transit, to prepay shipping charges to the warranty service location and to use the original shipping container or equivalent.

Alcatraz Al will in its sole discretion decide either to repair or replace the returned product. Repair parts and replacement products will be furnished on an exchange basis and will be either reconditioned or new. All replaced parts and products become the property of Alcatraz Al. This limited warranty does not include service to repair damage to the product resulting from accident, disaster, unreasonable use, misuse, abuse, customer's negligence, reseller's negligence, installation or service by other than an Alcatraz Al certified installer, or non-Alcatraz Al modification of the product. ### Extended Warranty Period

When products are purchased subject to a multi-year contract, the Warranty Period equals the length of the contract, as long as contract payments remain current. Furthermore, if a contract extension is executed before the then current contract ends, the Warranty Period is likewise extended. For example, if products are purchased for a contract length of three (3) years, the Warranty Periodisthree (3) years, and if a contract is extended for two (2) years, the Warranty Period is likewise extended by two (2) years, but only if the contract extension is executed before the previous contract has expired. If a contract expires before being extended, the Warranty Period reverts to one (1) year. If contract payments lapse, the Warranty Period reverts to one (1) year. IF A CONTRACT EXPIRES BEFORE BEING EXTENDED, OR IF CONTRACT PAYMENTS LAPSE, THE WARRANTY PERIOD IRREVOCABLY REVERTS TO ONE (1) YEAR.

#### Premium Service Plan Including Advanced Replacements

For customers which separately purchase premium service, after RMA is obtained, Alcatraz Al will expedite shipment of replacement products ("Advanced Replacements") before suspected defective products are returned. In this way the suspected defective products can be uninstalled, and products installed in their place, during one field service call, avoiding two separate service calls and resulting in a minimum of service interruption to the customer.

When Advanced Replacements are shipped, the suspected defective products must be received at the warranty service location within thirty (30) days of shipment of the Advanced Replacements. If the suspected defective products are not received within thirty (30 days, Alcatraz Al will invoice the purchaser for the then current list price of the Advanced Replacements, and payment for the Advanced Replacements will become due immediately.
